PREPARATION FOR THE CONFERENCE OF THE PARTIES

Liability and redress **

Note by the secretariat

1. The Conference of Plenipotentiaries on the Stockholm Convention adopted resolution 4 on liability and redress concerning the use and intentional introduction into the environment of persistent organic pollutants. Paragraph 1 of the resolution invited "Governments and relevant international organizations to provide the secretariat with information on national, regional and international measures and agreements on liability and redress, especially on persistent organic pollutants." Paragraph 2 of the resolution requested "the secretariat in cooperation with one or more States to organize a workshop on liability and redress in the context of the Convention on persistent organic pollutants and related matters, no later than 2002." Paragraph 3 of the resolution provides for the report of the workshop to be considered at the first session of the Conference of the Parties, "with a view to deciding what further action should be taken."

2. Pursuant to paragraph 1 of the resolution, the secretariat sent a letter on 14 September 2001 to Governments, members of the Inter-Organization Programme for the Sound Management of Chemicals (IOMC) and other relevant intergovernmental organizations, reminding them of the invitation by the Conference of Plenipotentiaries to provide information. A copy of this letter is included in Attachment 1 to the present note. As at 19 February 2002, responses had been received from the Governments of Austria, Bulgaria, Canada, Central African Republic, Czech Republic, Ethiopia, Georgia, Jordan, Kazakhstan, Madagascar, Mauritius, Peru, Singapore and United Kingdom, and from the European Commission, the secretariat of the Convention on Biological Diversity and the Organization for the Prohibition of Chemical Weapons. Copies of these responses are included in Attachment 2 to the present note.

Dear Colleague:

The Conference of Plenipotentiaries on the Stockholm Convention on Persistent Organic Pollutants held from 22 to 23 May 2001, in addition to adopting the Convention, adopted, <u>inter alia</u>, a resolution on liability and redress concerning the use and intentional introduction into the environment of persistent organic pollutants (reference: resolution 4, appendix 2 of UNEP/CONF/4).

The resolution invited Governments and relevant international organizations to provide the secretariat with information on national, regional and international measures and agreements on liability and redress, especially on persistent organic pollutants. It also requested the secretariat in cooperation with one or more States to organize a workshop on liability and redress in the context of the Convention on persistent organic pollutants and related matters, no later than 2002. The results of that workshop, which the Government of Austria has offered to host, would be considered at the first Conference of Parties to the Stockholm Convention.

In relation to initial information gathering requirement, the secretariat would be grateful to receive any information you may wish to submit concerning national, regional and international measures and agreements on liability and redress. Responses should be sent at your earliest convenience and no later than 31 December 2001. This will enable the secretariat to prepare for next year's workshop and to provide a progress report for consideration by the Intergovernmental Negotiating Committee (the interim authority for the Stockholm Convention) at its sixth meeting in June 2002.
