BASEL CONVENTION REGIONAL CENTRES FOR TRAINING AND TECHNOLOGY TRANSFER

Background

The Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and their Disposal provides in Article 14 for the establishment of Regional Centres. The main goal of the Basel Convention Regional Centres (BCRCs) is to strengthen the capacity of countries of the regions for the implementation of the Basel Convention. The Article stipulates that "according to the specific needs of different regions and sub-regions, regional or sub-regional centres for training and technology transfer regarding the management of hazardous wastes and other wastes and the minimisation of their generation should be established."

In consultation with the countries which expressed interest to host the centres, and through a series of feasibility studies, the potential host countries have been identified and endorsed in by the Parties in Decision III/19.

The following Basel Convention Regional Centres have been endorsed and established by the Parties to the Basel Convention:

- 1) For the African region: Egypt, South Africa, and Senegal (operative but not yet endorsed)¹ with Nigeria as coordinating centre
- 2) For the Asia and Pacific region: China and Indonesia²
- 3) For the Central and Eastern European region: the Slovak Republic and the Russian Federation
- 4) For Latin America and the Caribbean region: Argentina, El Salvador and Trinidad and Tobago with Uruguay as the coordinating centre.

The activities of the BCRCs are summarized in Annex I.

Having reviewed the status and activities of the BCRCs, the Conference of the Parties to the Basel Convention at its fifth meeting (December 1999), in decision V/5 (paragraph 17), requested the Secretariat to prepare a framework agreement, which will form the basis of a legally binding agreement to be concluded between the representatives of the governments hosting the BCRCs and the secretariat of the Basel Convention on behalf of the Parties.

The purpose of the Framework Agreement is to provide the centres a formal legal status as the regional mechanism for the implementation of the Basel Convention.

The Conference of the Parties to the Basel Convention, at its sixth meeting (9 to 13 December 2002 in Geneva) will consider the adoption of the Framework Agreement in a decision which also includes the financial mechanisms for the operation of the BCRCs, their membership, the core functions of BCRCs³ and the roles and functions of the Coordinating Centres of the Basel Convention. These elements are considered essential for the legal establishing and operation of the centres and ensuring their long-term sustainability.

The Strategic Plan for the Basel Convention, which will also be considered by the Conference of the Parties to the Basel Convention at its sixth meeting, calls on the further strengthening of BCRCs as effective

regional mechanisms to facilitate the coordinated implementation of the Basel Convention, its amendments and protocols, and related conventions and programmes.

Some of the specific activities of the Strategic Plan are: carrying out a review of the training and technology transfer needs of Parties in each region, development and implementation of common action plans and prioritised regional programmes, joint public awareness and information dissemination programmes on environmentally sound management including minimization of wastes and chemicals.

The BCRCs provide for regional infrastructures aimed at carrying out activities toward the coordinated implementation of the Basel and Stockholm Conventions. Some concrete activities have already been carried out like the First Regional Workshop for the Caribbean for the Management, Prevention and Environmentally Sound Management of Pesticides in the context of the Basel and Stockholm Conventions and the preparation of a regional project proposal for the environmentally sound management of pesticides (Trinidad, 22-25 April 2002) and the preparation of a Pilot Dioxins and Furans Assessment Project in Africa with specific focus on impact of specific local practices.

In the future, the Stockholm Convention involvement in the BCRCs could strengthen their viability, avoid duplication and enhance the collaboration between the Stockholm and Basel Conventions to support environmentally sound management of hazardous chemicals and wastes through their whole life-cycle, including production, use, trade and disposal.

ANNEX II4

CORE FUNCTIONS OF THE BASEL CONVENTION REGIONAL CENTRES

The role of the Centres is to assist developing countries and countries with economies in transition, within their own region, through capacity building for the environmentally sound management to achieve the fulfilment of the objectives of the Convention.

The description of the **core functions**⁵ of the Centres are as follows:

- 1. Training
- 2. Technology Transfer
- 3. Information
- 4. Consulting
- 5. Awareness

The explanations of the core functions of the Centres are as follows:

- (a) Developing and conducting training programmes, workshops, seminars and associated projects in the field of the environmentally sound management of hazardous wastes, transfer of environmentally sound technology and minimization of the generation of hazardous wastes with specific emphasis on training the trainers.
- (b) Identifying, developing and strengthening mechanisms for the transfer of technology in the field of the environmentally sound management of hazardous wastes or their minimization in the region.
- (c) Gathering, assessing and disseminating information in the field of hazardous wastes and other wastes to Parties of the region and to the Secretariat.
- (d) Collecting information on new or proven environmentally sound technologies and know-how relating to environmentally sound management and minimization of the generation of hazardous wastes and other wastes and disseminating these to Parties of the region at their request.
- (e) Establishing and maintaining regular exchange of information relevant to the provisions of the Basel Convention, and networking at the national and regional levels.
- (f) Organising meetings, symposiums and missions in the field, useful for carrying out these objectives in the region.
- (g) Providing assistance and advice to the Parties of the region at their request, on matters relevant to the environmentally sound management or minimization of hazardous wastes, the implementation of the provisions of the Basel Convention and other related matters.
- (h) Promoting public awareness.
- (i) Encouraging the best approaches, practices and methodologies for the environmentally sound management and minimization of the generation of hazardous wastes and other wastes, e.g. through case studies and pilot projects.

- (j) Cooperating with the United Nations and its bodies, in particular UNEP and the Specialised Agencies, and with other relevant intergovernmental organisations, industry and non-governmental organisations, and, where appropriate, with any other institution, in order to coordinate activities and develop and implement joint projects related to he provisions of the Basel Convention.
- (k) Developing, within the general financial strategy approved by the Parties, the Centres' own strategy for financial sustainability.
- (1) Cooperating in mobilisation of human, financial and material means in order to meet the urgent needs at the request of the Party (ies) of the region faced with incidents or accidents which cannot be solved with the means of the individual Party(ies) concerned.
- (m) Performing any other functions assigned to it by the decisions of the Conference of the Parties of the Basel Convention or by Parties of the region, consistent with such decisions.
