Subject: Follow up to decision INC-7/1 on budget for 2003 and 2004-2005

Dear colleagues,

At its seventh session held from 14 to 18 July 2004 in Geneva, Switzerland, the Intergovernmental Negotiating Committee for an International Legally Binding Instrument for Implementing International Action on Certain Persistent Organic Pollutants (INC) established a budget group. The group discussed and agreed on the elements that would be included in the budget of the Secretariat of the Stockholm Convention and how the overall budget should be presented. The outcome of group formed decision INC-7/1 on budget for 2003 and 2004-2005 that was adopted by the INC. This is found in annex I of the report of the session, document UNEP/POPS/INC.7/28. Paragraph 7 of the decision requested the Secretariat to develop a model budget presentation and format for consideration by the first session of the Conference of the Parties.

In response to this request, the Secretariat has prepared the attached draft model format on the basis of the deliberations of the budget group at the seventh session of the INC.

Any specific recommendations would be welcomed. Please note that budget elements used in the attached are generally agreed, but if you have recommendations that would help clarify the reporting please make them specific.
