

THE BUREAU PAVES THE WAY FOR A PAPERLESS COP

The Bureau of the Conference of the Parties (COP) met in Geneva on 5 October 2010 to discuss the preparation and approve the agenda for the upcoming meeting of the Conference of the Parties.

The Secretariat briefed the Bureau on the new activities that will be proposed for consideration of the COP next April. Activities, such as the Brokering Service - a programme destined to facilitate and coordinate access of eligible Parties to capacity assistance - and the joint capacity building activities between the Basel, Rotterdam and Stockholm Conventions will provide an important impetus to the technical assistance activities under the Convention.

OVERVIEW OF THE POPRC 6

At its sixth meeting, held in Geneva from 11 to 15 October 2010, the Persistent Organic Pollutants Review Committee adopted a dozen decisions. Among these, it adopted the risk management evaluation for endosulfan and recommended listing the chemical in Annex A of the Convention, with specific exemptions, a move that would lead to its elimination from the global market.

The Committee also adopted the risk profile on hexabromocyclododecane, a flame retardant, and decided it should proceed to develop a risk management evaluation. The decision-making on short-chained chlorinated paraffins was postponed until its eighth meeting in 2012, in order to gather more information on the industrial chemical's health effects and trends of levels in the environment.

In addition, the Committee reviewed information on the nine POPs that were listed in the Convention in May 2009, and made recommendations to the COP on the elimination of brominated diphenyl ethers from the waste stream and on the risk reduction for PFOS.

The Committee also finalized its guidance on alternatives to perfluorooctane sul-

fonates (PFOS), and agreed to conduct a study on toxic interactions of multiple chemicals, and to strengthen chemicals science on climate change and POPs. Recognizing the knowledge gap and the needs for enhancing capacity in collecting relevant information in developing countries and countries with economies in transition, the Committee decided to continue the activities to support effective participation of Parties in the review process.

POPRC will report its conclusions and recommendations to the fifth meeting of the Conference of the Parties (COP5), to be held from 25 to 29 April 2011 in Geneva.



THE BROKERING TOOL

The lack of financial means and technical capacity is a key barrier that hampers countries to implement their national priorities under the Stockholm Convention. Experiences gained in the past years in the implementation of the Convention suggest that a large number of countries still have essential capacity assistance needs and hence may not be able to make full use of funds provided under the financial mechanism of the Convention.

Developing country Parties and Parties with economies in transition have therefore requested the provision of further capacity assistance from countries in a position to do so. While capacity assistance activities are readily offered for a broad range of chemical issues, many recipient countries may not be aware of the full spectrum of activities provided at the global, regional and national level.

A likely reason for this shortcoming is a lack of knowledge on existing capacity assistance programmes and difficulties in accessing such information. At the same time, donor countries often lack more detailed information on the particular capacity assistance needs of recipient countries.

The Secretariat of the Stockholm Convention, in cooperation with the Secretariats of the Basel and Rotterdam Conventions, has responded to these needs by implementing a new initiative to overcome these barriers.

GLOBAL MONITORING PLAN MEETING IN GENEVA

The second meeting of the expert group to update the guidance on the Global Monitoring Plan (GMP) for POPs was held in Geneva, Switzerland, from 4 to 6 October 2010. Discussions focused on the ongoing revisions of a number of technical/analytical aspects of the guidance document reflecting the recent listing of nine new persistent organic pollutants in the annexes A, B and C to the Stockholm Convention.

Among the most prominent topics were the current activities on the analysis of perfluorinated chemicals in breast milk and serum, guidance on sampling of HCHs and PFOS in open ocean waters and large lakes, environmental specimen banking, and issues related to long range transport and climate effects on air sampling of POPs.

The revised guidance will be further submitted for consideration to the next meeting of the GMP global coordination group.

CLIMATE CHANGE MEETING

The meeting of experts on climate change and persistent organic pollutants was held from 6 to 8 October 2010 in Geneva, Switzerland. Twenty internationally recognized experts, including two members of the GMP global coordination group, participated in the discussions on the ongoing study that reviews recent scientific findings on the interlinkages between climate change and POPs, including releases into the environment, long range transport and environmental fate, human and environmental exposure and effects, as well as co-benefits of mitigation strategies for climate change and POPs emission reduction measures.

The meeting was also aimed at formulating policy recommendations to address coupled effects of climate change and POPs on the environment and human health. The final report of the expert group will be submitted to the fifth meeting of the Conference of the Parties to the Stockholm Convention to support the work on the effectiveness evaluation and the global monitoring plan for POPs.

OUTCOMES OF THE REGIONAL WORKSHOP IN KUWAIT

A regional workshop on the practical use of the guidelines on Best Available Techniques (BAT) and Best Environmental Practices (BEP) and the Environmentally Sound Management of PCBs and POPs wastes for Arabic-speaking countries as well as the Islamic Republic of Iran and Turkey, organised in cooperation with the Kuwait Institute for Scientific Research (KISR), a Stockholm Convention Regional Centre, was held in Kuwait City, Kuwait from 17 to 21 October 2010. Forty participants from governments, inter-governmental organisations (IGOs), non-governmental organisations (NGOs) and the private sector attended the regional workshop.

The workshop aimed at enhancing the exchange of experience among countries of the region on challenges encountered and measures undertaken at the national level to implement BAT and BEP to reduce unintentional releases of POPs and manage PCBs and POPs wastes.

Participants also had the opportunity to visit a steel mill plant and a medical waste incinerator which have introduced BAT and BEP successfully. The steel manufacturing plant

featured quality control of ferrous scrap, adequate off-gas treatment including post-combustion afterburners, followed by rapid quench of off-gases. Other measures included adsorbent injection (activated carbon) and high-level dedusting with fabric filters. The plant indicated that 10% of its total investment costs have been dedicated to greening the manufacturing process. Rapid return on investment is expected by ensuring high quality products.

The medical waste incinerator was also characterised by BAT and BEP through the segregation of different types of medical waste at the source. Appropriate treatment of bottom ashes and residues from flue gas cleaning was also performed.

Participants welcomed the opportunity given to experience a practical on-site training presenting practices and processes that constitute BAT and BEP as listed in the guidelines to reduce releases of unintentional POPs adopted by the Conference of the Parties.

SYNERGIES WORKSHOP IN SAN SALVADOR

As part of the joint activities currently being implemented in light of the Synergies decision, the Secretariats of the Basel, Rotterdam and Stockholm Conventions in collaboration with the Basel regional centre in El Salvador are organizing a regional workshop for Central America and the Caribbean to be held 6-9 December in San Salvador.

The objective of the workshop is to offer a holistic approach to the three Conventions, including enhancing cooperation and coordination when implementing the Conventions. Among others the workshop will provide training on resource mobilization, focusing on how to use the guidance on resource mobilization developed by UNITAR in collaboration with the Rotterdam Secretariat.

Nominations to participate in the workshop must be submitted to the Stockholm Convention Secretariat through the official channels as soon as possible but **no later than 10 November 2010**.
