Item 1

In accordance with the terms of reference of the Committee, prior to the meeting and using a correspondence procedure the Committee members will meet in closed session to review issues pertaining to conflicts of interest.

Item 4

Review of the outcomes of the tenth meeting of the Conference of the Parties to the Stockholm Convention on Persistent Organic Pollutants that are relevant to the work of the Committee

7. The tenth meeting of the Conference of the Parties to the Stockholm Convention on Persistent Organic Pollutants was held in Geneva from 6 to 17 June 2022, back to back with the fifteenth meeting of the Conference of the Parties to the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal and the tenth meeting of the Conference of the Parties to the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade. The outcomes of the tenth meeting of the Conference of the Parties to the Stockholm Convention relevant to the work of the Committee are described in document UNEP/POPS/POPRC.18/INF/4. The Committee may wish to take note of the information provided.

(i) Dechlorane Plus

8. (ii) Chlorinated paraffins with carbon chain lengths in the range C₁₄₋₁₇ and chlorination levels at or exceeding 45 per cent chlorine by weight
