Why Webinars?

Webinars are a complement to the face-to face training activities organized by the Secretariat of the Stockholm Convention. Through tailored information and



knowledge exchange, the POPs Webinars allow for an interactive dialogue between the Secretariat, experts and government officials involved in the implementation and enforcement of the Convention. By doing so, the Secretariat aims at supporting Parties in addressing some of the challenges they may face when implementing the Convention.
