- 13. An online training of three days is planned in September 2015 on national reporting for the Caribbean Region in cooperation with the Regional Centre located in Trinidad and Tobago.
- 14. A sub-regional training workshop was held in Senegal from 6 to 9 July 2014 to support French-speaking countries in Africa to meet their reporting obligations under Stockholm and Basel conventions. The workshop was organized in cooperation with the Basel and Stockholm Convention Regional Centre in Senegal. The training targeted countries that have started the process of reviewing and updating their national implementation plans (NIPs) and brought together national officials from 17 French-speaking African countries.

#### National legislation for the Basel Convention and enforcement activities

- 15. Two webinar sessions were organized on 6 and 11 February to present the various guidance documents available to parties to develop and review their national legislation implementing the Basel Convention.
- 16. A three-day online training on illegal traffic of hazardous wastes and other wastes with simultaneous interpretation from English into Spanish was organized on 21 and 24 November 2014, for the Latin American Region in cooperation with the Regional Centre located in Argentina.

#### **Environmentally sound dismantling of ships**

17. Continuation of a capacity building project to ensure the environmentally sound management of waste from ship dismantling in Bangladesh and Pakistan: project preparation phase completed. The Secretariat is retaining consultants for the project and organising initial stakeholder consultation meetings in Bangladesh and Pakistan for August 2014.<sup>33</sup>

#### Environmentally sound management of PCBs

18. Webinars were organized on several topics such as: PCB inventories and draft technical guidelines on the ESM of POPs wastes.

#### Other

19. Training methodologies are being developed and training modules on different themes have been developed. - 9. Draft guidance documents to improve decision-making on managing DDT in disease vector control and tools for the assessment of locally effective and affordable alternatives to DDT were developed in collaboration with WHO. Two regional workshops are scheduled to be held in Africa and Asia in 2015 to promote using the guidance documents towards sound management of DDT and for the promotion of non-chemical alternatives.
- 10. DDT expert group met in November 2014 and prepared its reports on the assessment of production and use of DDT including the use of alternatives for consideration by the Conference of the Parties in its evaluation of continued need for DDT.

- 14. A report on the assessment of alternatives to PFOS was prepared by POPRC.
- 15. A report for the evaluation of information on PFOS was prepared by the Secretariat, taking into account the comments and suggestions provided by POPRC.
- 16. A report was prepared highlighting the main challenges encountered by parties in implementing the recommendations set out in the annex to decision POPRC-6/2 on the elimination of BDEs from the waste stream and on risk reduction for PFOS.
- 17. A preliminary assessment of efforts made towards the elimination of polychlorinated biphenyls was elaborated by UNEP Chemicals, in cooperation with the Secretariat, and with the expert input from the PEN advisory committee. The Secretariat assisted with the organization of the fifth meeting of the Committee which was held in Geneva on 26 and 27 November 2014.

- 7. A review of arrears in assessed contributions has been undertaken and letters to parties with contributions in arrears have been sent out in March 2014. In addition, a Note Verbale has been sent by FAO to the Italian authorities regarding their late payment of host country contributions.
- 8. Continuing efforts to further enhance efficiency in the use of financial and human resources within the secretariat in the biennium 2014-2015.

Regarding section II (Organization of the secretariats of the Basel, Rotterdam and Stockholm conventions), and section VI (Transparency and accountability) of the omnibus decisions taken in 2013, the following activities have been implemented:

- (i) Legal and policy activities related to trade and environment issues pertaining to the Basel, Rotterdam and Stockholm conventions with the WTO and other UN entities were initiated; synergies between the Basel, Rotterdam and Stockholm conventions were identified: cooperative efforts and work on these issues, with relevant partners, including the Basel and Stockholm conventions regional centres, were enhanced, as parties called for it during the 2013 COPs meetings. The Secretariat participated in and provided input to several meetings, consultations, courses and other events attended by representatives of parties and WTO Member States, on WTO/MEAs cross-cutting issues. Information and expertise were exchanged; assistance was mutually provided on issues and activities of common interest: e.g. in 2013, the Secretariat contributed to the updating of the WTO matrix on trade-related measures in MEAs (See also documents UNEP/CHW.12/INF/31, UNEP/FAO/RC/COP.7/INF/20 and UNEP/POPS/COP.7/INF/41.);
- (j) Legal and policy activities related to environment and human rights pertaining to the Basel, Rotterdam and Stockholm conventions, were undertaken: the Secretariat participated in and worked on activities and issues of common interest with the Office of the High Commissioner for Human Rights (OHCHR) in particular the Special Rapporteur on the implications for human rights of the environmentally sound management and disposal of hazardous substances and wastes and at the Human Rights Council as well as with other relevant entities, including the Secretariat of the Aarhus Convention, UNEP divisions (See also documents UNEP/CHW.12/INF/31, UNEP/FAO/RC/COP.7/INF/20 and UNEP/POPS/COP.7/INF/41.);
- (k) Corporate legal operations were carried out through various activities: the initiating, drafting, negotiation, conclusion and execution of series of legal instruments; legal advice, analysis, training and guidance were provided to staff, parties and other relevant stakeholders on legal instruments and other corporate legal and policy issues pertaining to human resources, ethics, intellectual property (e.g. the protection of names/emblems and other intellectual property work produced through activities developed to facilitate implementation of the conventions), dispute resolution, among others:

## National legislation, illegal traffic and trade, and enforcement under the Basel, Rotterdam and Stockholm conventions

- 3. Specific to the Basel Convention (see document UNEP/CHW.12/11):
  - (a) Assistance was provided to 10 parties on request to address alleged cases of illegal traffic and resolve differences between parties;
  - (b) Information was collected from three parties on their best practices in preventing and combating illegal traffic, and posted on the website;
  - (c) The Secretariat continued its cooperation with enforcement organizations and networks;
  - (d) The Secretariat supported the work of the Environmental Network for Optimizing Regulatory Compliance on Illegal Traffic (ENFORCE), including by organizing its 1<sup>st</sup> meeting (Bangkok, 18-19 November 2013), by supporting its activities (development of a gaps and needs analysis), by organizing online consultations on 25 June 2014 and 14 October 2014, and by performing other secretariat functions<sup>76</sup> (see document UNEP/CHW.12/16).
- 4. Basel, Rotterdam and Stockholm conventions:
  - (a) The Secretariat continued its cooperation with enforcement organizations and networks including by: finalizing the e-learning tool of the enforcement of the Basel, Rotterdam and Stockholm conventions developed in cooperation with Interpol; and making progress in the publication of the Secretariat's e-manual on the enforcement of the conventions for customs and the finalization of the e-learning tool with WCO. The Secretariat has also continued its cooperation with the Regional Enforcement Network for Chemicals and Waste (REN) and the Green Customs Initiative (GCI) Partners (see document UNEP/CHW.12/11);
  - (b) Legal technical assistance webinars were launched in December 2013 on tools developed to help parties in adopting adequate legal frameworks implementing the Basel, Rotterdam and Stockholm conventions. Two workshops on illegal traffic of hazardous wastes and other wastes were organized by the Secretariat in Argentina, 28 and 29 August 2013 and in Colombia, 10-12 December 2014 (see document UNEP/CHW.12/INF/22-UNEP/FAO/RC/COP.7/INF/14-UNEP/POPS/COP.7/INF/17);
  - (c) Following receipt of a financial contribution in November 2014 the Secretariat initiated the hiring of a consultant to prepare an analysis on possible synergies under the Basel, Rotterdam, and Stockholm conventions in combating illegal traffic and trade in hazardous chemicals and wastes, building on lessons learned under the Basel Convention (see document UNEP/CHW.12/INF/51).
- A concept note for fundraising for activities in the area of national legislation, illegal traffic and trade, and enforcement was developed and posted on the synergies website.
