## 1. Exemptions

Decision: SC-10/5: Exemptions

Background:

In decision SC-10/5, the Conference of the Parties, among other things, reminded Parties wishing to register for specific exemptions and acceptable purposes, articles in use and closed-system site-limited intermediates to notify the Secretariat. The Conference of the Parties also invited Parties and others to provide information on short-chain chlorinated paraffins and decabromodiphenyl ether.

## 2. DDT

Decision: SC-10/6: DDT

Background:

By decision SC-10/6, the Conference of the Parties, among other things, noted that the global use of DDT for disease vector control continued to decline and that countries currently using DDT for disease vector control had a target date of 2030 for malaria elimination. The Conference of the Parties invited the 18 Parties currently included in the register of acceptable purposes for DDT to review their needs regarding the use of DDT and to transmit a revised notification adjusted to the present needs or withdraw from the register by 31 December 2022.

Decision: SC-10/7: Polychlorinated biphenyls

Background:

By decision SC-10/7, the Conference of the Parties, among other things, took note of the draft guidance on a standardized approach to developing inventories of polychlorinated biphenyls, and invited Parties and observers to provide comments on the draft guidance by 30 November 2022. The Conference of the Parties also urged Parties to provide information on progress in eliminating polychlorinated biphenyls in their fifth national reports to be submitted, pursuant to Article 15 of the Convention, by 31 August 2022.

#### **4. Evaluation and review of brominated diphenyl ethers pursuant to paragraph 2 of parts IV and V of Annex A to the Stockholm Convention**

**Decision:** SC-10/8: Evaluation and review of brominated diphenyl ethers pursuant to paragraph 2 of parts IV and V of Annex A to the Stockholm Convention

**Background:**

By decision SC-10/8, the Conference of the Parties, among other things, decided to undertake an evaluation of the progress that Parties have made towards eliminating brominated diphenyl ethers contained in articles and a review of the continued need for specific exemptions for those chemicals at its twelfth meeting, in accordance with the process set out in the annex to decision SC-6/3 and the schedule set out in the annex to decision SC-10/8. The Conference of the Parties furthermore urged Parties currently registered for specific exemptions for the use of brominated diphenyl ethers to review their continued need for such registration and to make the resulting information available to the Secretariat to facilitate the evaluation and review of brominated diphenyl ethers.

## 5. Guidelines and guidance on best available techniques and best environmental practices

Decision: SC-10/9: Guidelines and guidance on best available techniques and best environmental practices

### Background:

By decision SC-10/9, the Conference of the Parties, among other things, encouraged Parties and others to use the guidelines and guidance on best available techniques and best environmental practices when applying measures to minimize and ultimately eliminate releases of the chemicals listed in Annex A or B, and/or C to the Convention, and to provide feedback on their usefulness. The Conference of the Parties also invited Parties and others with relevant expertise to nominate experts to the joint Toolkit and best available techniques and best environmental practices expert roster, and to contribute to the further review and update of the guidelines and guidance, in accordance with the workplan referred to in paragraph 4 of decision SC-10/9, by submitting new relevant technical information and information on the successful application of best available techniques and best environmental practices relevant to the chemicals listed in Annex A or B, and/or C to the Convention. The Conference of the Parties furthermore encouraged Parties to report on estimated releases of dioxins and furans under Article 15 of the Convention.
