# 9. Request for information for the assessment of funding needs

#### Background:

At its seventh meeting, the Conference of the Parties adopted decision SC-7/18 on the assessment of funding needs which contains two separate requests for information.

In paragraph 5 of the decision, the Conference of the Parties invited developed country parties, other parties and other sources, including relevant funding institutions and the private sector, to provide information to the Secretariat on ways in which they can support the Stockholm Convention. On the basis of the information submitted, the Secretariat was requested to prepare a report reviewing the availability of financial resources additional to those provided through the Global Environment Facility and the ways and means of mobilizing and channelling such resources in support of the objectives of the Convention.

The work to be carried out under these terms of reference will be facilitated and coordinated by the Secretariat with a view to enabling a team of up to three independent experts to undertake, over a period of up to three months, a full assessment of the funding necessary and available for the implementation of the Convention for this period.
